

- (3) That the Head Office of the trust shall be D-27 Sec 12 Pratap Vihar GHAZIABAD(U.P) OR at such place or places, as the author of the trust and trustees by a majority, decide from time to time
- (4) That the author of the trust, shall during his life time or so long as he wills, remain a trustee of the trust and shall have the privilege to remain as Chairman of the body of trustees and shall preside at all the meetings of the trust and it shall not be competent for the body of the trustees by any rules made or resolution passed to deprive him of this right. But he may waive such right when and so often as he may please. He shall have a casting vote also.
- (5) That after his death his wife Smt. Neetu Singh shall be the Chairman of the body of the trustees and after her death her son Aarav Nirwan -or ( his guardian appointed by Mrs. Neetu Singh in case he is minor till he is an Adult shall be the Chairman of the body of the Trustees )
- (6) That succeeding Chairman / Chairperson i.e. Neetu Singh and after her Aarav Nirwan shall have same rights and privileges as the author of the trust.

- (7) That the author of the trust and after him the trustees by a 2/3rd majority may appoint any other person to be trustee provided that the total no. of the trustee shall not exceed Nine.
- (8) Any trustee may retire on giving one month's notice in writing to the Chairman of the trust.
- (9) A trustee will be liable to be removed by a 2/3<sup>rd</sup> majority of the body of trustees for any thing done, prejudicial or detrimental to the interest of the trust i.e. misappropriating of trust funds for causing will full damage or harm to the trust's property or any misconduct on his/her part in the discharge of his/her function as a trustees.
- (10) on the occurrence of a vacancy in the body of the trust, the author of the trust or his wife and after their death the body of trustees, by a simple majority may appoint any of the descendants of the outgoing trustee in his/her place.
- (11) In all the meetings of the trustees, 2/3<sup>rd</sup> will form the quorum.
- (12) In the case of any difference among the trustees, the opinion of the author of the trust or his wife in their life tenure and afterwards the opinion of the majority shall prevail.
- (13) The trustees may delegate all or any of the powers, authorities discretion conferred on them to any committee or committees. Such a committee may consist of either some of the trustees or some of the trustees together with any other person or persons not being trustees whom the trustees may at any time revoke either wholly or partly the authority conferred on any such committee.
- (14) The author of the trust, the trustees, their relations, friends or any other person may make voluntary contributions either by way of donation, annual or other subscriptions or legacy or otherwise for the support or for the benefit of the trust hereby constituted and declared.

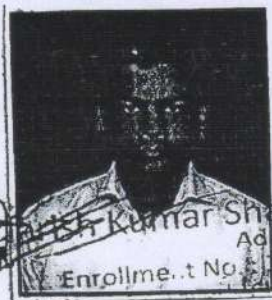

- (15) The sums of money obtained by the trust by donations, subscriptions or as income from or as sale of any moveable or immovable property which is ever comes in the ownership of the trust, shall be called Trust funds and shall invested in Bank Deposits, Govt, bond or such other appropriate securities as the board of trustees may decide.
- (16) The income from the trust funds, after defraying all costs, or expenses of or incidental to the administration of the trust shall be applied and used for the charitable or religious purposes only as enumerated above, and not for any other private use of the trustees.
- (17) The work and function of the trust shall be carried out by the chairman of the trust on behalf of the trustees.
- (18) It shall be lawful for the trustees to decide by circulation and any such resolution or decision shall be effective as resolution passed at a meeting of the trustees.
- (19) Proper accounts for the trust shall be kept at the office of the trust.
- (20) A general meeting of the trustees shall be held once at least in every year at Deepawali at which accounts of the trust and a report concerning the working of the trust shall by be prepared and presented by the Chairman of the trust and at which decision shall be taken about the grant of reward, aid, scholarship stipends etc. to the members of the general public and other important activities of the trust.
- (21) The trustees shall have the power to regulate their proceedings and if necessary to frame rules and regulation for any purpose and /or in connection with the meetings and/or from time to time repeal, amend, add to or alter the same.




